KEYNOTE SPEAKER



STEVEN PERLMAN, DDS

Dr. Steven Perlman is a Clinical Professor of Pediatric Dentistry at the Boston University Goldman School of Dental Medicine. For the past 40 years, he has devoted much of his private practice as well as his teaching to the treatment of children and adults with physical and intellectual disabilities.

Dr. Perlman is a past president of the Academy of Dentistry for Persons with Disabilities, the Massachusetts Academy of Pediatric Dentistry and the American Academy of Developmental Medicine and Dentistry. He is a Fellow of the Academy of Dentistry for Persons with Disabilities, a Fellow of the American College of Dentists and a Diplomate of the American Board of Special Care Dentistry.

Dr. Perlman was the first dentist in Massachusetts to receive the Exceptional Physician Award. He is a Distinguished Alumnus of the Boston University Goldman School of Dental

Medicine and the first graduate in the history of the Dental School to also be recognized as a Distinguished Alumnus of Boston University.

He is the recipient of the Harold Berk Award from the Academy of Dentistry for Persons with Disabilities and the Manny Album Award from the American Academy of Pediatric Dentistry. Both awards are the highest honors of the organizations recognizing lifetime achievement in the care of people with disabilities.

Dr. Perlman has also been honored by the Pierre Fauchard Academy, and in 2002 the American Dental Association presented him with their Access Recognition Award.

In May 2002, the American Academy of Pediatric Dentistry Foundation named Dr. Perlman Dentist of the Year for his significant contributions to the dental profession and the specialty of pediatric dentistry over an entire career of distinguished service.

He has published over 300 articles, co-edited a textbook, *Treating the Dental Patient with a Developmental Disorder*, and was a contributor to the Surgeon General's Report on Oral Health in 2001.

In 2005, Dr. Perlman received the Exceptional Parent Maxwell J. Schileifer Distinguished Service Award for dedication to improving the lives of individuals with special needs and disabilities as well as the Trudi Birger Community Service Award from Alpha Omega for extraordinary contribution to children with special needs all over the world.

In 1993, Dr. Perlman founded Special Olympics Special Smiles, an oral health initiative for the athletes of Special Olympics International. It now has over 200 events each year taking place in every state in the United States and in over 100 countries. He currently serves as their Senior Global Clinical Advisor.

Dr. Perlman is cofounder and past president of the American Academy of Developmental Medicine and Dentistry (AADMD) and in 2005 and 2006 served as an advisor to the President's Committee for Persons with Intellectual Disabilities.

RUTH ALEJANDRO, MD

Dr. Ruth Alejandro is a board-certified physiatrist. She graduated from New York Medical College. She completed her Physical Medicine & Rehabilitation Residency at NYPH-University of Columbia and Cornwell where she was Chief Resident. Her expertise includes spasticity management (Botox, Intrathecal Baclofen Pump Maintenance), SCI rehabilitation, amputee prosthetic rehabilitation, and wound care. She is the Program Director of the Blythedale Rotation of NYPH-University Hospital of Columbia & Cornell PM&R Residency Program and New York Medical College PM&R Residency Program. She is also an assistant Clinical Professor, Columbia University Department of Rehabilitation & Regenerative Medicine. Dr. Alejandro has spoken at numerous conferences in the past and received various awards and honors including Teacher of the Year award in 2016 from the New York Medical College Dept. of Physical Medicine and Rehabilitation.

RITA BILELLO, DDS

Dr. Rita Marie Bilello joined the team at Metro Community Health Centers (an FQHC designed to assist individuals with developmental disabilities and their families) after nearly twenty years in private dental practice. While working as a clinical dentist in a large family practice she began to work more closely with the developmentally disabled population. She partnered with HeartShare Wellness in Brooklyn, NY to develop a dental clinic that served not only the general population but that would also address the specific needs of the developmentally disabled population. Providing not only direct dental care to these underserved patients, but also instructing and training other dentists in the special requirements that this population requires, is something that Dr. Bilello works to achieve daily. Dr. Bilello received her Bachelor of Fine Arts from Colgate University in upstate New York and then pursued her degree in dentistry at New York University College of Dentistry in Manhattan. While at NYU she was invited to participate in several honors programs and was inducted into Omega Kappa Upsilon, the national dental honor society. After graduation Dr. Bilello completed a general practice residency at North Shore University Hospital in Manhasset, NY and was selected to extend her employment as the Chief Resident in Dentistry. She joined Raphaelson Dental Associates as an associate dentist and

continued to expand upon her education by attending continuing education lectures and seminars. She maintains her private practice on the weekends while pursuing her passion for special care dentistry full time at Metro Community Health Centers. While at Metro Community Health Centers she has worked closely with New York University College of Dentistry in the development of their Oral Health Center for People with Disabilities which is anticipated to open in January 2019.



RICHARD COHEN, PhD

Dr. Richard Cohen is a NYS Licensed Psychologist who has worked in the field of Developmental Disabilities for over 30 years. He currently is the Director of Behavioral Health for Metro Community

Health Centers (an FQHC designed to assist individuals with developmental disabilities and their families). Prior to this, Dr. Cohen was the Chief of Mental Health for YAI/NIPD's Center for Specialty Therapy (Article 16 Clinic) and Primer HealthCare (Article 28 Clinic). Dr. Cohen has extensive experience as a Psychological Supervisor for both Residential and Day Services.

DIANKAH ELIGON

Diankah Eligon is a NYS licensed Physical Therapist. She is a graduate of Long Island University-Brooklyn Campus receiving a Doctorate and Master's Degree in Physical Therapy. Diankah currently works for Cerebral Palsy Associations of NYS as the Physical Therapy Services Supervisor for the Day Programs, Clinics and Residences. She has extensive experience in custom wheelchair assessments and rehabilitation of people with intellectual disabilities. Services she has provided include Neuromuscular Rehabilitation, Geriatric and Orthopedic Rehabilitation, Orthotics, Wound Care Management, Staff Training and Development. Diankah has participated in Special Olympics as the lead trainer for a FIT training project for the NY Floor Hockey Team in January of 2017. She continues to treat and deliver professional quality care at CP of NYS and works closely with the Director of Rehab and other department heads to maximize quality and efficient patient care.

ELIZABETH FOGLIA

Elizabeth A. Foglia, MA, CCC-SLP is a New York State licensed speech-language pathologist who has been providing skilled intervention to adults with developmental disabilities for the past 15 years. She also has experience providing therapy to children in the Early Intervention Program. Her specialties include Augmentative and Alternative Communication and Dysphagia. In addition, she has an interest in Dementia. Elizabeth graduated from the University at Buffalo, where she earned both her Bachelor's and Master's degrees. Currently, Elizabeth is an off-site clinical supervisor for Buffalo State College. She is placed at Aspire of WNY, where she serves individuals who attend an adult day program as well as outpatients (including typically developing adults and adults with developmental disabilities). Elizabeth taught the graduate AAC course at Buffalo State College for 2 years as an adjunct professor. She has completed Augmentative and Alternative Communication presentations at Buffalo Hearing and Speech Center and Dysphagia presentations at Developmental Disabilities Day (Niagara Falls Convention Center), Buffalo State College and Aspire of WNY.

JESSICA HEBRANK MD

Jessica Hebrank, MD is board-certified in adult psychiatry and child and adolescent psychiatry. Dr. Hebrank is a partner of the Hudson Valley Psychiatric Associates and consults at various mental health centers in the Hudson Valley and Capital Region. Dr. Hebrank's client base is varied and spans the stages of development. Her area of interest is working with non-verbal children and adolescents that are diagnosed with Autism.

developmental disabilities (I/DD) across the lifespan. He has previously served as Medical Director for other I/DD Article 28, Article 16 clinics, and long-term residential programs. He has been involved in all Article 28 clinics attaining NCQA Patient Centered Medical Home recognition and establishing and supervising clinical rotations at his clinics for medical students and residents to ensure future physicians gain experience in providing care to patients with disabilities. He's the Medical Director of the Alliance for Integrated Care of N.Y., the first Accountable Care Organization with a focus on patients with IDD. He's an appointed member of the Central Mortality Review committee for OPWDD (Office for People With Developmental Disabilities). He received his M.D. degree from the University of Santo Tomas in Manila, Philippines, completed his residency training at St. Clare's Hospital in Schenectady, N.Y., and obtained his M.B.A. degree from Adelphi University in Garden City, N.Y. and is a member of the business honor society, Beta Gamma Sigma.

BEHAVIORS, MEDICATIONS AND TEETH - OH MY!

Rita Bilello, DDS, Metro Dental Director, Metro Community Health Centers

This session will focus on the need for medical providers to be aware of the oral manifestations as well as oral complications related to treating patients with complex I/DD diagnoses. Dr. Bilello will look into some of the behaviors most commonly associated with both dental treatment and incidents of dental pain. Often patients with I/DD do not demonstrate dental symptoms in a typical fashion. The presenter will also investigate some of the more commonly utilized medications that impact a patient's oral health. Medications impact not only the physical condition of the mouth by affecting the tissues and function directly but they also impact a patient's ability to tolerate dental treatment. Finally, some of the challenges of providing dental treatment to the IDD/DD population will be discussed along with some strategies on how to overcome these both in the clinical and residential settings.


