In an effort to streamline the process to register for IPA/Navigator/Certified Application Counselor (CAC) courses, we are implementing an on-line registration process for the three-day Navigator/CAC training program and for other training programs as offered. This easy process will allow you to view the training schedule and to register directly on-line.

Begin by entering the requested information on the Sign Up home page:

- You will be prompted to create a unique username and password. Once created, you will see a message that . confirms the username and password entered. This message is also emailed to you in case you forget them.
- The last step is to log in using your username and password. Once you complete this process, the course registration "Welcome" page will open.



• Click on "My Courses", click "View" for a list of available courses, locations and the dates/times offered.



- Click "Enroll" to select the desired course session from the list.
  - Each course session has a maximum enrollment and registration deadline. If a session reaches maximum enrollment, a notification will display on the screen to select a different date. Enrollment must be completed 48 hours prior to the session start date.
- Once "Enroll" is selected, this completes the enrollment process and you will receive a confirmation email.
  Enrollment can be changed and/or canceled via the on-line registration process.
- To change or cancel: Sign-in, select "My Courses", click on "View" and choose "Change Session" or "Cancel Session".
  - If you or a member of your staff are unable to attend a session, please be sure to update the registration status to allow others an opportunity to register.
