



The Jeffrey T. Latman Foundation Finance Scholarships

Information about the Scholarship

- **The Jeffrey T. Latman Foundation is a national organization providing financial assistance to community health centers and the institutions that support them;**
- **Jeffrey T. Latman was a Partner of Goldstein Golub Kessler & Company, P.C. who was a national visionary leader in community health center finance;**
- **The Jeffrey T. Latman Foundation has provided \$20,000 in funding that is used to support scholarships that will specifically cover registration fees for the CHCANYS 2008 and 2009 fall conference Financial Tracks; and**
- **CHCANYS will review all applicants and make a determination by September 23, 2009. Approximately 22 slots are available for 2009.**

Eligibility Criteria

- **All HRSA-grantees regardless of membership status in CHCANYS are eligible to apply;**
- **Up to \$12,850 in scholarships/registration fees will be granted to 22 individuals from health centers in New York State in 2009;**
- **Potentially one individual CFO, Fiscal Manager, or Fiscal staff person is eligible to apply per health center in New York State as approved by the CEO or the organization;**
- **Special consideration for a scholarship is based on demonstrated fiscal needs of the health center, geographic distance from the conference site (Rye Brook); and the need to train staff (e.g. new FQHC or LookAlike, improvement in fiscal knowledge or capacity indicated by HRSA, new staff member).**

Requirements of Recipient

- **Scholarships only cover the cost of full conference registration of \$580 for the period of Wednesday, October 14- Friday, October 16 and recipients are expected to attend all CHCANYS Finance/Operations/CFO Learning Team sessions relevant to their work;**
- **Scholarships do not cover the cost of lodging or transportation to the conference, but are intended to help offset expenses for centers who may not otherwise be able to have a staff person benefit from participation;**
- **Signing of an attendance sheet and completion of an evaluation form is required of the scholarship recipient; and**
- **Attendees may be requested to attend a CFO/ Latman Scholars meeting during the conference, which will also serve as a networking experience for scholarship recipients.**
