

HOW TO TALK TO YOUR LEGISLATORS ABOUT COMMUNITY HEALTH CENTERS: FOUR KEY REASONS WHY CHCs ARE IMPORTANT

1. COMMUNITY HEALTH CENTERS ARE THE COMMUNITIES THEY SERVE...

- Over 400 community health center advocates statewide and _____ from your community are in Albany today with a very important message -- community, migrant and homeless health centers are integral to New York's primary care safety net.
- Community health centers are locally owned and operated non-profit entities, with the majority of their boards comprised of health center patients.
 - o Introduce any community Board Members in the meeting.

2. EVERY DAY, OUR COMMUNITY HEALTH CENTERS DELIVERY QUALITY CARE TO THOUSANDS OF NEW YORKERS, FROM BUFFALO TO BROOKLYN...

- CHCs serve 1.4 million people who would otherwise go without care.
 - Provide a personal example have a patient or staff member <u>briefly</u> tell how they or someone they treated received care they otherwise would not have received.
 - Let your legislators know just how proud you are of your community health center.

3. COMMUNITY HEALTH CENTERS DELIVER HIGH QUALITY CARE TO THEIR PATIENTS...

- CHCs are responsive to their communities' individual needs, and they improve health and prevention by using a locally-tailored <u>health care home model</u>.
 - Of the 30 health centers statewide who had responded to a CHCANYS survey as of January 2012, 83% had at least one site that had achieved Patient Centered Medical Home (PCMH) recognition at any level and 63% had at least one site that had achieved Level III recognition (the highest level).

- CHCs excel at care coordination and disease management, keeping patients out of emergency rooms.
 - Health centers improve rates of important preventive screening services and offer prenatal services that improve birth outcomes and reduce health disparities.
 - Health centers have been proven to significantly reduce the expected lifetime incidence of diabetes complications, including blindness, kidney failure, and certain forms of heart disease.
- Health centers rapidly incorporate and share evidence-based quality improvement practices and are investing in electronic health records to enhance and better coordinate patient care.
 - New York has one of the highest rates of EHR implementation in the nation. Statewide, 97% of health centers have implemented EHRs or have an implementation in progress; EHR implementation rate for New York City's FQHCs is 100%.
 - o Tell your legislators when your health center adopted EHRs and how it is improving care.

 - Maintain the Executive Budget's proposed \$430,000 for continued funding for community health centers serving migrant and seasonal farm workers and their families.
 - Support the Executive Budget's proposed \$1 million for the Primary Care Service Corps.
